Visiting Landis Homes? Here's what you need to know!

Residential Living Visitors

Updated June 17, 2021

- All visitors screened at self-screening stations in Crossings or Residential Living entrance, even if they have been vaccinated or have had COVID-19. Name badge obtained and worn while on campus.
- Visitation in resident accommodations, including overnight, at resident discretion. Guests may be in common areas unless otherwise noted. The pool and fitness center remain closed to guests.
- Follow all regulatory guidelines including wearing a face covering, practicing hand hygiene and maintaining a minimum of six feet of physical distance.
- Outside guests are now allowed to dine in the Azalea Room and the Owl Hill Bistro (not the Garden Room at this time). Visitors should wear masks until seated at a table. Each table may include up to four people. Dogwood Café remains closed to residents and guests.
- Guest accommodations continue to remain closed at this time. Reservations for family gatherings and guest accommodations will be available later this summer. Details of when and how to make reservations will be shared at a future date. Please do not call for reservations at this time.

Personal Care Visitors

Updated June 8, 2021

- General in-person visitation on Monday Friday will be available from 9:00 11:30 a.m. and 1:30 – 4:00 p.m. and will no longer require a scheduled appointment.
- General in-person visitation on evenings and weekend will continue to be scheduled through emailing: <u>familyconection@landishomes.org</u> or by calling 717-509-5409.
- There will be a maximum of two (2) visitors per resident room, including a child of any age.
- Individuals age 2 and over must wear face coverings, regardless of vaccination status.
- Weekday visitors must pass screening at the Personal Care entrance between 9:00 -11:30 a.m. and 1:30 – 4:00 p.m. Monday – Friday. Evening and weekend scheduled visitors must screen at the Dogwood entrance. A visitor's vaccination status does not eliminate any of the screening requirements.
- Visitors must visit in resident rooms only. Visitors are not permitted to visit in common areas or the Dogwood Café. Outside visitation with masks is acceptable with only the two visitors that have passed screening.
- Personal Care residents who have been vaccinated may choose to have close contact with their visitor in their room while wearing a well-fitted mask.
- General in-person visitation accessibility will continue based on the status of the households related to exposure and other potential limiting scenarios (county positivity rate and percentage of residents vaccinated). Residents in households that are Green (no known COVID exposure) will be eligible for in-person visits. Residents in household that are yellow (known COVID exposure) and Red (COVID positive) will be eligible for Compassionate Caregiver visits only.
- If there is an outbreak (one resident or a team member tests positive), all Personal Care visitation will be paused until outbreak testing is be completed. Please understand this affects all visits in all Personal Care households and can happen quickly. Status of visitation will be posted at the Personal Care entrance.
- DHS, CMS, and the Centers for Disease Control (CDC) continue to emphasize the importance of maintaining infection control practices, given the continued risk of COVID-19 transmission. Any visitors not following the core principles of infection control will be asked to leave immediately.

Healthcare Visitors

Updated June 8, 2021

- Healthcare visits are guided by the most recent local, state and federal guidance. Types of visits include Compassionate Caregiver visits (including end of life visits) and General Visits which may be window, indoor, or outdoor visits depending on the status of the household. Visits may now take place in resident rooms depending on the status of the household, the county positivity rate, and the percentage of residents vaccinated.
- Visitors are required to follow infection control preventions strategies, including properlywearing a face covering at all time, hand hygiene, and practicing social distancing. Additional PPE will be provided, as necessary.
- All visits are **scheduled** through the volunteer services office, 717.509.5409 or <u>familyconnection@landishomes.org</u>. Visit locations will be shared at scheduling
- General in-person visitation accessibility will continue based on the status of the households related to exposure and other potential limiting scenarios (county positivity rate and percentage of residents vaccinated). Residents in households that are Green (no known COVID exposure) will be eligible for in-person visits. Residents in household that are yellow (known COVID exposure) and Red (COVID positive) will be eligible for Compassionate Caregiver visits only.
- If there is an outbreak (one resident or a team member tests positive), all Healthcare visitation will be paused until outbreak testing is be completed. Please understand this affects all visits in all Healthcare households and can happen quickly.
- DOH, CMS, and the Centers for Disease Control (CDC) continue to emphasize the importance of maintaining infection control practices, given the continued risk of COVID-19 transmission. Any visitors not following the core principles of infection control will be asked to leave immediately.
