Mitigating actions implemented to prevent or reduce the risk of transmission include, but are not limited to:

- Visitors are required to complete symptom screening and required education. If an outbreak occurs, visitation may be limited.
- Symptom screening for team members before assigned shift
- Universal masking for all team members and use of personal protective equipment (PPE), as needed, with each resident encounter



- Active symptom screening for all residents, masking when in the presence of others, as tolerated, limited movement outside houses or rooms to essential activities only, and modified dining and life enrichment programs to eliminate large group gathering.
- Residents are admitted or readmitted to a designated area, staffed by designated team members for a minimum of 14 days of monitoring including transmission-based precautions. Resident vaccination status and potential exposures may alter the admission location.
